

### STIPULATION TO CHANGE CUSTODY

1. Fill in your file number in the space provided - (year-docket number-case type)
2. Print your name and address and the other party in the spaces provided for Plaintiff and Defendant. The person who initiated the Summons and/or Complaint is always be the Plaintiff.
3. Fill the name(s) of the children for whom custody is being changed.

### Pursuant to this Stipulation to Change Custody

4. Check the appropriate spaces for legal custody. If joint custody, both Plaintiff and Defendant box should be checked along with joint. If one party has sole custody you must CHECK ONE, *either* Plaintiff or Defendant and sole custody (*only one parent can have sole custody*).
5. Check the appropriate box for physical custody. Same instructions as above.
6. Fill in the effective date of custody.
7. Both parties must have their **signatures notarized**.
8. **Return this form completely filled out and signed to the Friend of the Court office.**

### ORDER

We will submit the stipulation to the 50<sup>th</sup> Circuit Judge for signature and upon which the Order Changing Custody will be filed and copies mailed to both parties.

### NOTICE

*The entire form must be completed in its entirety before it will become an Order. If it is not complete, or if completed incorrectly, upon submission to the Friend of the Court office this document will be placed in your file without any action being taken.*
