**CHIPPEWA COUNTY BOARD OF COMMISSIONERS**

**RESOLUTION TO AUTHORIZE THE CONTINUATION OF THE  
DECLARATION OF THE STATE OF EMERGENCY FOR THE  
COUNTY OF CHIPPEWA**

WHEREAS, on March 22, 2020, the County of Chippewa, as a result of the Corona Virus (COVID-19) pandemic, the State of Emergency declared by the Governor, and a National State of Emergency declared by the President of the United States, the following conditions continue to exist: and

WHEREAS, any widespread outbreak within the County of Chippewa could hinder and/or cease most daily operations within the entire County and overwhelm, Emergency Medical Services, Hospitals and Urgent Cares; because of monitoring requirements that is placed on the local health department personnel, additional staff and resources may be needed if the current status of health concerns continue to deteriorate and

THEREFORE, BE IT RESOLVED, that the Chippewa County Board of Commissioners, in accordance with Section 10 of 1976 PA 390, as amended, hereby declare a “state of emergency” continues to exist within our jurisdiction as of November 12, 2020, and that local resources and funding are being utilized to the fullest possible extent. The County EOC will continue to be partially activated along with the county emergency operations plan.


