## Chippewa County Correctional Facility PREA STATMENT

PREA 28 CFR §115.17 prohibits the hiring, promotion or otherwise enlisting the services of anyone who may have contact with an individual incarcerated or detained at a correctional facility who has engaged in, been convicted of, or been civilly or administratively adjudicated for engaging in sexual abuse or sexual activity facilitated by force in confinement settings or the community.
