## 1. Call to Order:

# 6. Finance Director Report:

- Finance Director Gordon reported that the Audit is tentatively scheduled for the week of December 5<sup>th</sup>, 2022.
- Finance Director Gordon reviewed the Draft September 2022 Financials and stated that the auditors may make minor adjustments during their audit and the GASB 68 adjustment will be made. Gordon stated that the board will see a significant difference in the MERS line item comparatively. Last year's number reflected the GASB 68 audit adjustment, this year it has not been made yet. The adjustment is based on the most recent actuary of EUPTA's pension plan.
- Gordon presented the Electronic Funds Report and Accounts Payable Report.

Bussing: Gordon reported that EUPTA's FYE fare revenue increased by 3% and passengers increased 21%, which is almost back to pre-Covid numbers. Most of the fare revenue is derived from either RTW and our 20-punch ticket. Total expenses have increased 11.69% with most of that being fuel. The fuel line item increased 56.48%. Gordon stated that the Travel/Meetings/Training line item shows an increase of over \$10,000 but this includes driver training material we purchased that was reimbursed 100% through our RTAP program which is reflected on the financials.

Ferry: Fare revenue for the year was down 6%, vehicle traffic was down 4% with passengers down 2%. The increase in expenses is around 9% once the MERS adjustment is made when the auditors come.

Gordon reviewed the graphs.

# 7. Director's Report:

- Facility Update: Director Paramski reported that everything is going as planned and they are making great progress.
- Cashless Update: Paramski stated that this is currently in a holding pattern and as we find bus, testing continues. Weekly meetings continue but progress is slow.
- Neebish III Update: Paramski reported that the boat was delivered 10/30/22 and is currently tied of at the end of the Rock Cut. It was a four-day trip as they only traveled during daylight hours. Both of the EUPTA mechanics were there for a debriefing and training on the boat. Mechanics will be doing testing, training and familiarizing themselves with the boat this week. Sea Trials will be on 11/8/22 and the dedication service will take place on 11/9/22.
- Drummond IV Update: Paramski reported that the dry dock is going well.
- Paramski stated with the departure of Trustee German, we should put election of Vice Chair on the December agenda.
